ALL OUR MEMBERS,

Decisions of Ordinary General Meeting of Istanbul Gold Exchange which was held on 04/03/2010 are as follows:

- Current custody fee taken at 0.0004 (four in ten thousand) level has changed as 0.0003 (three in ten thousand).
- Current transaction fee for precious metals (gold, silver and platinum) from ore processing included transactions for buyer and seller are the same of precious metals (gold, silver and platinum) from ore processing taken at 0.00005 (five to hundred thousand) level has changed as 0.00015 (one and a half in ten thousand) level and that fee is applied at a rate four times for transactions for buyer and seller are the same of precious metals from ore processing.
- Effective custody fee that is applied for precious metals at the time of delivery is also applied for precious metals from ore processing.

Capital Market of Board approved the above decisions with the official letter dated March 29, 2010 numbered B.02.1.SPK.0.16-327-3183. New fees will apply as of the date 06/04/2010.

These changes are announced for information and necessary.
